## ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 1 – General inquiry posted looking at an incident in the far turn before ¾. The incident did not affect the top 4 finishers. No. 3 NORTHERN LÜCKY LEI (Odell Cross) finished sixth placed eighth for interference to trailing horses while on a break.

Race 5 – Inquiry posted on unofficial second place finisher No. 2 POSSUM HOLLER (Brandon Bates) for possible interference to unofficial third place finisher No. 5 ALWAYS CALL (Kyle Wilfong) at the top of the stretch. The two drivers briefly got hooked entering the stretch, however, it appeared Mr. Bates' horse was running out and Mr. Wilfong's was bearing in at the same time. The judges felt that both were equally at fault and therefore no placings were made.

John Delong, driver of No. 2 NOTORIOUS LUCK, fined \$200.00 for whipping with more than minimal wrist and elbow action.

Race 6 - No. 8 BROOKLETS SONIC was first time Lasix. Announcements made via TV scroll and track announcer.
