




Race 4 - The judges activated the yellow caution lights after No. 1 MIKI'S BIG GUY broke a line going into the first turn before the quarter. Fortunately the outrider was able to catch the horse going up the backside and no one else in the race was adversely affected.

Race 6 – No. 7 MISS DIOR (Marvin Luna) originally finished fifth placed tenth for violation of the breaking rule (extended break).

Race 10 – Inquiry posted on unofficial fourth place finisher No. 1 SWEET SANDY (Brandon Bates) for possible violation of the breaking rule at the start. After reviewing video the judges determined that Mr. Bates complied with the breaking rule and the horse was placed as finished.
