


Race 12 - Dan O'Mara, trainer of No. 7 SHADOWRAGE, fined \$200.00 for missing his scheduled paddock time.


Race 4 - Inquiry posted on unofficial fourth place finisher No. 2 GALLEYS IMAGE (Marvin Luna) for possible violation of the breaking rule in the stretch. Replay showed that the horse was off stride nearing the finish and through the wire. The horse was lapped on by only one horse. No. 2 GALLEYS IMAGE finished fourth placed fifth for violation of the breaking rule (lapped on break).

Race 6 - The test barn reported possible welts on race winner No. 5 DUNBAR HALL (Atlee Bender).

Race 7 - Inquiry posted regarding whether No. 2 NORTHERN LUCKYGIRL (Kyle Wilfong) made the fair start pole. Video showed that the horse was inside of the pole by the time the rest of the field was released by the starter. No. 2 NORTHERN LUCKYGIRL declared a starter for wagering purposes.
