### ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

**Race 3** - Inquiry posted concerning No. 9 SHEZA COOKIE (Don Eash) and the fair start pole. Video showed that the horse had not yet passed the fair start pole prior to the remainder of the field being released by the starter. No. 9 SHEZA COOKIE declared a non-starter for wagering purposes and refunds were issued on any bets made involving the horse.

**Race 4** - No. 7 LYNDY'S NAVIGATOR was not on Lasix but did wear trotting hobbles (as per normal). Announcements made via TV scroll and track announcer.

**Race 9** - No. 8 COCA CHIA was first time Lasix. Announcements made via TV scroll and track announcer.

**Race 9** - Inquiry posted on unofficial fourth place finisher No. 5 BROOKLETS LIKEITIS (Kyle Wilfong) for possible violation of the breaking rule after 3/4. After reviewing video the judges determined that Mr. Wilfong complied with the breaking rule and there was no reason for disqualification.



**Race 10** – Inquiry posted on unofficial race winner No. 6 FAMOUS FATHER (Atlee Bender) for possible pylon violation after  $\frac{3}{4}$  entering the top of the stretch. Video showed that while Mr. Bender was inside of two pylons he was not lapped on and the judges determined he did not gain an unfair advantage. No reason for disqualification, but Mr. Bender fined \$100.00 for the pylon violation.

**Race 11** – Mike Oosting, driver of No. 5 BELIKETHIS, fined \$200.00 for violation of the whipping rule.

**Race 12** – No. 2 ROCKINWITHDAVE (Carson Conrad) originally finished fifth placed tenth for causing horses up the backside going to the half. Mr. Conrad ran up on the horse in front of him, causing his horse to abruptly slow which in turn caused a chain reaction of horses jamming up behind him. For this violation Mr. Conrad is fined \$200.00.
