**Race 3** – Inquiry posted on unofficial fourth place finisher No. 6 SWAN SO FINE (Trace Tetrick) for possible violation of the breaking rule entering the backstretch past the quarter. Video showed that driver Tetrick complied with all aspects of the breaking rule and the horse was placed as finished.

**Race 7** – No. 9 BOB LEE BELL (Marvin Luna) originally finished seventh placed ninth for violation of the breaking rule (lapped on break)

**Race 9** – Peter Wrenn, driver of No. 1 EPIC HIT, fined \$100.00 for failure to come up into position. Mr. Wrenn has requested a hearing on this matter.
