ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 1 - No. 1 LUVIN AFFECTION (Brandon Bates) originally finished seventh placed eight for causing interference to No. 4 FULL COVERAGE (Doug Rideout) in the stretch. Mr. Bates hooked Mr. Rideout from behind. Mr. Bates fined \$200.00 for interference causing a placing.

Race 3 - Jordan Ross, driver of No. 3 ALWAYS B RICKI, fined \$300.00 for causing welts to the horse. Mr. Ross requested a hearing.

Race 7 - No. 2 BLUEBIRD CHOIR raced without trotting hobbles. This was a program error, and announcements were made of the correction via TV scroll and track announcer.

Race 9 - No. 7 EXPERT TUTOR (Don Eash) originally finished seventh placed tenth for a pylon violation in the stretch. Mr. Eash gained an unfair advantage by going inside the pylons and passing horses. Mr. Eash fined \$200.00 for the pylon violation.

Race 10 – No. 6 KOA was a late vet scratch after it was brought to the judges attention that the horse had an open wound due to a recent throat surgery. With this scratch and the earlier scratch of NORTHERN CADILAC the field was reduced to five betting interests. Per IHRC rules, superfecta wagering on the race was cancelled.

Race 12 – No. 3 SOMETHING GREATER (John DeLong) originally finished sixth placed eighth for violation of the breaking rule in the stretch.
