
**Race 5** – Inquiry posted on unofficial third place finisher No. 9 CRUISIN JUKE (Ricky Macomber, Jr.) for possible interference to unofficial ninth place finisher No. 5 DIRTY IMAGE (Jordan Ross) at the top of the stretch. While video showed that Mr. Macomber struck and flattened Mr. Ross' tire it also showed that Mr. Ross' horse ran out into the path of Mr. Macomber's at that point. Mr. Ross helpfully pointed that out when the judges spoke with him. With no fault to Mr. Macomber, there was no reason for disqualification and the horses were placed as finished.





# Harrah's Hoosier Park IHRC Judges' Daily Report
