### ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

**Race 4** – Inquiry posted on unofficial race winner No. 2 LIKE A CHAMPION (Marvin Luna) for possible pylon violation at the top of the stretch. Replay showed that Mr. Luna stuck two pylons, but never was inside of them. The judges determined no violation occurred and the horse was placed as finished.

**Race 7** – No. 10 PEACE PRIZE (Marvin Luna) originally finished seventh placed ninth for a pylon violation in the far turn before 3/4s.


**Race 8** – Inquiry posted on unofficial fourth place finisher No. 5 WINSLOW (Dan Shetler) for possible of the breaking rule in the stretch. No. 5 WINSLOW was off stride through the finish and while off stride was lapped on by unofficial third place finisher No. 3 BROOKVIEW EL ZORRO (Trace Tetrick). For violation of the breaking rule (lapped on break) WINSLOW finished fourth placed fifth.





