## ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Races 1, 14 - Driver Devon Tharps fined \$200.00 for failure to drive when programmed.

Peter Wrenn, driver of No. 3 FLIRTNWITHTHEPILOT, warned about brining his elbow too far back and up around his head.

Race 7 – Inquiry posted on unofficial third place finisher No. 6 FIRST OPTION (Dan Shetler) for possible violation of the breaking rule after the start. Video confirmed that Mr. Shetler's horse did not make an extended break and that he complied with all aspects of the breaking rule. No violation and the horse was placed as finished.
