Jared Seekman, driver of No. 10 LENWOODS REAL DEAL, warned about brining his arm too far back while whipping in the stretch.

Race 6 – No. 8 HEZA R REAL DIAMOND (Jared Seekman) originally finished eighth placed ninth for interference to trailing horses while on a break before 3/4.
