

ADMINISTRATIVE ACTIONS, NOTES, COMMENTS


Race 4 - Inquiry posted unofficial race winner No. 2 WALKIN ON SUNSHINE (Ricky Macomber, Jr.) for possible interference to unofficial second place finisher No. 6 ROLLIN ROSIE (Trace Tetrick) after ¾ entering the top of the stretch. Video showed that No. 2 WALKIN ON SUNSHINE came out late causing driver Tetrick to grab his horse up and change course. This was confirmed by Mr. Tetrick. With the winning margin being only a head, the judges determined that this interference was significant enough to merit a placing. No. 2 WALKIN ON SUNSHINE finished first placed second. Driver Ricky Macomber, Jr. fined \$200.00 for causing interference.

Race 5 - No. 3 DAS SCHNIPKER (Trace Tetrick) originally finished eighth placed ninth for violation of the breaking rule (lapped on break).

Race 10 - Inquiry posted on unofficial second place finisher No. 4 LYIN' EYES (Joey Putnam) for possible interference to No. unofficial third place finisher No. 1 TEELATINI (John DeLong) in the stretch. After reviewing videos and speaking with both drivers the judges determined that no interference occurred, and the horses were placed as finished.
