## ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 3 – General inquiry posted concerning the actions of unofficial tenth place finisher No. 4 ROWAN'S TATER TOT (Matt Krueger) in the stretch. Video showed that No. 1 ON THE TOWN (Carson Conrad) was tiring at the top of the stretch and Kruger sitting directly behind him ran up on the No. 1 causing his own horse to make a break. No. 4 ROWAN'S TATER TOT charted with a "dx" (driver caused break).

Race 6 - No. 6 BROOKLETS LIKEITIS (Kyle Wilfong) charted with an equipment break before 34 and will not have to qualify despite not finishing the race.

Race 7 - Recall charged to No. 7 MILK N HONEY for causing interference while on a break before the start.
