ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 13 – Inquiry posted on unofficial race winner No. 2 M-M-S BUD (Jay Cross) for possible pylon violation in the far turn. Replay showed that the horse was inside at least two consecutive pylons twice before entering the stretch. While the horse was not lapped on the judges felt that it gave the horse enough of an advantage between the winning horse and second place finisher No. 1 ROLLING IMAGE (Trace Tetrick). For a pylon violation No. 2 M-M-S BUD finished first placed second. Driver Jay Cross fined \$200.00 for a pylon violation with placing.

Marvin Luna, driver of fifth place finisher No. 4 MARTZ TELLY (Marvin Luna) fined \$200.00 for causing interference to fourth place finisher No. 6 SHOOTING IN PLACE (Atlee Bender) in the stretch.
