### ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

**Race 1** – Claim on No. 2 DANS CREDIT voided due to no transfer fee being included with the claim. Tote delay prior to the start of the first race caused a 15-minute delay. The judges sent the horses back to the paddock. TV screens in house were not affected and kept current odds and pools. The decision was made to continue racing while mutuels attempted to find a solution to the tote board issues.  
 No. 7 WEGOFORTHEFRONT (John DeLong) finished sixth placed eighth for violation of the breaking rule in the stretch (extended break).  
**Race 8** – No.1 BROOKVIEW BOLT (Trace Tetrick) originally finished sixth placed seventh for interference to trailing horses while on a break.  
**Race 12** – Recall charge to No. 7 THREEFIFTYTWO for interference to No. 6 DUNBAR HALL before the start.
