## ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Video confirmed that Mr. Bender was inside multiple pylons in the stretch and passed horses while inside. For gaining an unfair advantage while inside the pylons No. 6 FASHION'S WAY finished fourth placed tenth. Driver Bender fined \$200.00.

Race 8 – Inquiry posted on unofficial fourth place finisher No. 5 PEACE PRIZE (Brad Ferguson) for possible interference to trailing horses on the far turn before 3/4s. Video showed that No. 5 PEACE PRIZE made a break which caused interference to No. 3 unofficial eighth place finisher No. 3 ROCKIN STANDO (LeWayne Miller) and unofficial seventh place finisher No. 9

Race 9 – Inquiry posted on unofficial fourth place finisher No. 6 YO FITTY (Brad Ferguson) for possible violation of the breaking rule in late stretch. Video confirmed that driver Ferguson complied with all aspects of the breaking rule and while off stride was not lapped on at the finish. No reason for disqualification and the horse was placed as finished.
