Race 8 – Kyle Wilfong, driver of No. 3 LATE NITE HAWK, fined \$200.00 for whipping with more than minimal wrist and elbow action while in the stretch.

Race 11 – General inquiry posted regarding No. 5 DASH OF LUCK (Jordan Ross) and whether that horse made the fair start pole. Video showed that the horse had not crossed the fair start pole prior to the rest of the field being released by the starter. No. 5 DASH OF LUCK declared a non-starter for wagering purposes. Refunds issued on all bets involving the horse.
