

### ADMINISTRATIVE ACTIONS, NOTES, COMMENTS


**Race 1** - Inquiry posted on unofficial race winner No. 5 SWEET N SPEEDY (Clint Coy) for possible jamming up and causing confusion to trailing horses. After speaking with drivers Mike Oosting (BLUEBIRD VANESSA) and Jordan Ross (WIGGLESNWINE) the judges determined there was not enough evidence to justify placing No. 5 SWEET N SPEEDY. Horse placed as originally finished.

**Race 2** - Trace Tetric driver of No. 7 KNOWYOUcando fined \$200.00 for striking the wheel of No. 5 BIG DOVER (Jordan Ross) and flattening the tire. No. 7 KNOWYOUcando finished sixth placed seventh for causing interference.

**Race 4** - Inquiry posted on unofficial third place finisher No. 4 HEART SONG for possible violation of the breaking rule after the ¼. Video showed that driver Putnam complied with all aspects of the breaking rule and therefore no violation. Horse was placed as originally finished.
