Replay confirmed that while off stride Nos. 1,4,6, and 7 all had to take action and move to avoid the breaking horse. For interference while on a break No. 3 FREAKY FEET BEAST finished third placed sixth (behind the impeded horse that finished furthest back in the race.)
