


Race 2 – Inquiry posted on unofficial fourth place finisher No. 4 DAN'S CREDIT (Trace Tetric) for possible violation of the breaking rule in the stretch. Video showed that the horse made a break in late stretch through the finish. Unofficial fifth place finisher No. 3 THREEFIFTYTWO (Rick Plano) was lapped on the horse. For violation of the breaking rule (lapped on break) No. 4 DANS CREDIT finished fourth placed fifth.


Race 4 – No. 4 MAYBEMABEL (Mike Oosting) broke a hople after the half and did not finish. Horse was charted with "be".

Race 5 – Inquiry posted on unofficial second place finisher no. 4 PLAYS IN THE SHADE (John De Long) for possible violation of the breaking rule before the start. Video confirmed that driver John De Long complied with all aspects of the breaking rule and there was no reason for placing.

Race 12 – Inquiry posted on unofficial fifth place finisher No. 6 LOVE ME HILL (Brandon Bates) for possible violation of the breaking rule before the quarter. Video showed that the horse made a brief break but driver Bates complied with the breaking rule. No violation and the horse was placed as finished.
