


ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 1 - Starter Todd Nixon fined Tyler Miller, driver of No. 4 AMONG THE MISSING, for crossing over before the start of the race.

Race 7 - Inquiry posted on unofficial third place finisher No. 6 K MAN JACK (Michael Knicley) for possible interference to trailing horses past the quarter entering the backstretch. After speaking with drivers Atlee Bender, Jordan Ross, and Michael Knicley the judges determined that Mr. Knicley grabbed his horse abruptly which caused confusion to trailing horses. The judges also determined that the confusion was great enough to merit a placing. No. 6 K MAN JACK finished third placed sixth. Mr. Knicley fined \$300.00 for jamming up and causing confusion.
