ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 6 – Inquiry posted on unofficial second place finisher No. 4 UPNAWAY BLUE CHIP (Brandon Bates) for possible passing lane violation and interference in the stretch to unofficial sixth place finisher No. 3 LATIN LOVER (Kyle Wilfong). After reviewing video and speaking with both drivers the judges determined that No. 4 UPNAWAY BLUE CHIP entered the passing lane without having the need to use and continued to drive down towards the pylons which impeded No. 3 LATIN LOVER. For interference and the passing lane violation No. 4 UPNAWAY BLUE CHIP finished second placed sixth. Driver Bates fined \$200.00 for the violation.

Race 10 - No. 3 MONTY'S MISSION (Kyle Wilfong) originally finished sixth placed seventh for violation of the breaking rule; extended break.
