## ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 3 – Inquiry posted concerning the start of the race and whether No. 7 GREAT FLICK (John DeLong) made the fair start pole. Video confirmed that the horse had not yet passed the fair start pole prior to the rest of the field being released by the starter. No. 7 GREAT FLICK declared a non-starter for wagering purposes. Refunds issued on any wagers placed on the horse.

Race 4 - No. 8 FIFTY DOLLAR NOTE originally finished sixth placed eight for a pylon violation in the far turn. No penalty to driver Wyatt Avenatti as the violation occurred while the horse was regaining stride after making a break.

Race 5 - No. 5 NIKOGIRL (John DeLong) originally finished sixth placed seventh for a lapped on break.
