ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 3 – LeWayne Miller, driver of No. 7 CREAKY fined \$100.00 for coming to the gate out of position causing a recall. The fine was later rescinded by the judges after a couple of drivers questioned whether the starter told them the correct number of the horse that was scratched.

Race 4 - Inquiry posted on unofficial second place finisher No. 2 EXPERT TUTOR for possible violation of the breaking rule in the stretch. Replay showed that No. 2 EXPERT TUTOR made a break before the finish and was off stride through the finish. The horse was lapped on by one other horse. For a lapped on break No. 2 EXPERT TUTOR finished second place third.

Race 8 - Erv Miller, trainer of No. 2 MEADOWBROOK DIO, fined \$100.00 for failure to have the horse properly equipped causing the horse to miss the post parade.
