



### ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

**Race 2** - Separate inquiries posted regarding No. 2 BLUEBIRD LOLA (Trace Tetrick) and the fair start pole and No. 1 ME MONTANA (Peter Wrenn) for a possible pylon violation in the far turn. Video confirmed that No. 2 BLUEBIRD LOLA was past the fair start pole when the remainder of the field was released by the starter. Video also showed that Mr. Wrenn struck pylons, but never was inside any. No reason for disqualification and the horse was placed as finished.

**Race 12** - Inquiry posted on unofficial race winner No. 1 MIRACLE MAVEN (John DeLong) for possible pylon violation in the stretch. After reviewing video the judges determined that the horse was not inside any pylons. No violation and the horse was placed as finished.
