### ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

**Race 6** - Recall charged to No. 1 UNDENIABLE BLUECHIP (Trace Tetrick) for scoring ahead of the gate.

**Race 7** - Inquiry posted on unofficial second place finisher No. 6 ONE DAN SHOW (Peter Wrenn) for possible violation of the breaking rule after the start. After reviewing video the judges determined that Mr. Wrenn complied with all aspects of the breaking rule. No. 3 BROOKVIEW EL ZORRO (Jordan Ross) originally finished fifth (dead heat) placed sixth for a passing lane violation. Jordan Ross fined \$200.00 for the passing lane violation.

**Race 8** - Inquiry posted on unofficial fourth place finisher No. 7 STARLITFRANKNSTEIN (Trace Tetrick) for possible violation of the breaking rule in the stretch. While the judges determined that driver Trace Tetrick complied with the breaking rule the horse still made an extended break (was off stride 25+ strides). For violation of the breaking rule No. 7 STARLITFRANKNSTEIN finished fourth placed seventh.
