ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 1 – Inquiry posted on unofficial fourth place finisher No. 4 DEVINE SWAN (Brandon Bates) for possible violation of the breaking rule in the stretch. After reviewing the video the judges determined no violation occurred and the horse was placed as finished.

Race 6 – LeWayne Miller fined \$100.00 foe failure to drive when programmed.

Race 7 – Inquiry posted on unofficial fourth place finisher No. 2 ULTIMATE LOULOU (Marvin Luna) for possible pylon violation in the far turn before ¾. Video showed that Luna's inside wheel was inside two consecutive pylons. The horse was lapped on by one horse at the finish. Per IHRC rules the horse is placed behind any horses it was lapped on. No. 2 ULTIMATE LOULOU finished fourth placed fifth. Marvin Luna fined \$200.00 for a pylon violation causing a placing.

Race 9 – No. 1 MYSTICAL LANE (Mike Oosting) originally finished fifth placed sixth for interference to No. 6 LAND OF FREEDOM (Jordan Ross) in the stretch. Driver Mike Oosting fined \$200.00 for interference causing a placing.
