Race 2 - Inquiry posted on unofficial fourth place finisher No. 1 FIFTY TO WIN (Ricky Macomber, Jr.) for possible violation of the breaking rule before 34. After reviewing video the judges determined that driver Macomber complied with the breaking rule and there was no reason to place the horses.

Race 4 – Inquiry posted on unofficial fourth place finisher No. 6 M-M'S TONY for possible pylon violation in the stretch. Video showed that the horse was inside two pylons and while inside pylons passed horses. For gaining an unfair advantage while inside of pylons No. 6 M-M'S TONY finished fourth placed seventh. Driver LeWayne Miller fined \$200.00 for a pylon violation causing a placing.

Race 7 – No. 2 SKYWAY MASTERPIECE originally finished fifth placed seventh (last) for a pylon violation in the far turn before 3/4s. Video showed that the horse was inside three consecutive pylons and per IHRC rules a horse may be placed last for that type of violation. Driver DeLong fined \$200.00 for a pylon violation causing a placing.
