## ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

(steward's list - break off qualifier)

Race 2 - Darrell Wright, driver of No. 6 GO LONG, fined \$100.00 for failure to come up into position.

Race 5 – With the scratch of No. 4 ON HIGHER GROUND the field was reduced to five betting interests. Per IHRC wagering rules, superfecta wagering on the race was cancelled.

Inquiry posted on unofficial third place finisher No. 6 PONDA JET (Kyle Wilfong) for possible violation of the breaking rule at the start. Video confirmed that while the horse was briefly on a break driver Wilfong was able to comply with the breaking rule.

Race 10 – Two separate inquiries posted. The first looking at an incident going to the half. While on the lead it appeared that No. 3 THE HAZELTON(Kyle Wilfong) jammed up horses behind him causing confusion. After reviewing video of the incident and speaking with driver Kyle Wilfong the judges determined that by slowing the pace he cause interference to trailing horses and caused No. 4 COUNTRY DAGGER to make a break, Driver Devon Tharps fined \$200.00 for jamming up and causing confusion.

Second inquiry posted on unofficial second place finisher No. 5 TRIATHALON AS (Brandon Bates) for possible interference to unofficial third place finisher No. 2 NIKO MAN (Marvin Luna) in the passing lane. After speaking with Mr. Liuna and reviewing video of the incident, the judges felt that there was not enough evidence to warrant a disqualification.
