



ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 3 - Randy D Crisler, driver of No. 3 SPARTACUS BLUECHIP, fined \$300.00 for excessive whipping in the stretch which far exceeded the minimal wrist and elbow portion of the whipping rule.

Race 9 - Inquiry posted on unofficial third place finisher No. 5 KID TYLER (Trace Tetrack) for possible pylon violation in the far turn before 3/4. Video showed that KID TYLER was inside two pylons and lapped on by one horse at the finish. Per IHRC rules with the horse committing the pylon violation being inside of two consecutive pylons it shall be placed behind any horse it is lapped on by at the finish. No. 5 KID TYLER finished third placed fourth. Driver Trace Tetrack fined \$200.00.
