### ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

**Race 6** – Inquiry posted on unofficial third place finisher No. 1 AHVA SHOLUM (Daryl Bontrager) for possible violation of the breaking rule after the start. The judges determined that driver Bontrager complied with the breaking rule and there was no reason for disqualification. Horse placed as finished.

**Race 10** – No. 2 KILMARTINCOMMANDER and No. 7 EVERYBODYLUVJOE both first time Lasix.

**Race 11** – Inquiry posted on unofficial third place finisher No. 6 CHEERS TO THAT (Kyle Husted) for possible jamming and causing confusion to trailing horses after the quarter. After speaking with several drivers the judges determined that the filly tried to pull herself up and in doing so caused confusion to trailing horses. Horse placed seventh, but no penalty to driver Kyle Husted.

**Race 12** - Inquiry posted on unofficial fourth place finisher no. 1 STRAIGHT MYSTERY (Mike Peterson) for possible violation of the breaking rule before the half. Video showed that while on a break the horse interfered with No. 8 OUR MONEY HEIST who ended up finishing second, ahead of No. 1. Driver Mike Peterson took the horse inside the pylons up the

backstretch. for safety reasons as he had nowhere to go outside. While inside the pylons Peterson complied with the breaking rule continuously losing ground and reentered the track before the turn trailing the field. Taking all of this into account the judges determined there was no reason for placing the horse.
