


ADMINISTRATIVE ACTIONS, NOTES, COMMENTS


Race 3 - Recall charged to No. 9 LIGHTHOUSE JESSE (Jordan Ross) for coming to the gate out of position. Jordan Ross fined \$100.00 by starter Todd Nixon for coming to the gate out of position causing a recall.

Race 6 - Inquiry posted on unofficial fourth place finisher No. 10 GOOD LUCK MARK (Jay Cross) for possible violation of the breaking rule after the start. While driver Cross complied with the breaking rule, the horse was still on a break for more than 25 strides which in Indiana constitutes an extended break. For violation of the breaking rule (extended break) No. 10 GOOD LUCK MARK finished fourth placed tenth.

Race 9 - Inquiry posted on unofficial race winner No. 3 BIG LAW (Ricky Macomber, Jr.) for possible interference to unofficial fourth place finisher No. 2 MADDIE'S JET LADY (Trace Tetric) for possible interference in the far turn after 3/4. After reviewing video and speaking with Mr. Tetric the judges determined there was not enough evidence to warrant a placing.
