Race 4 - Inquiry/objection posted on unofficial third place finisher No. 4 BOOK THE FLIGHT (Mike Oosting) for possible interference to No. 7 MARKGETSETGO (Brandon Bates) after 3/4 entering the stretch. Video showed that No. 2 DRAMA CRITIC (Mike Peterson) making a bad step at that point driver Oosting comes out into the path of No. 7 MARKSETGO causing interference to that horse, this was confirmed speaking with both drivers. For interference No. 4 BOOK THE FLIGHT finished third placed fifth. No penalty to driver Oosting.
