ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 6 - Inquiry posted on unofficial third place finisher No. 3 MOREHELPFORSALLY (Kyle Wilfong) for possible violation of the breaking rule after the start. Replay confirmed that the horse was on a break for more than 25 strides, For violation of the breaking rule (extended break) No.3 MOREHELPFORSALLY finished third placed ninth.

Race 11 - With the scratches of FIFTY DOLLAR NOTE, MIRACLE MAVEN, FRUIT SNACKER, the field was reduced to four betting interests. Per IHRC wagering rules, trifecta and superfecta wagering on the race was cancelled. The track cancelled show wagering.

Race 12 - No. 6 MASTER SHAWN (John DeLong) originally finished seventh placed eighth for violation of the breaking rule in the stretch.
