Video showed that No. 4 INCREDIBLE LUCK was stopping and was struck from behind by No. 5 TELL'S BELLS causing TELL'S BELLS to make a break, fall, then hit the ground. No. 5 TELL'S BELLS got up immediately under her own power as driver Ross never became unseated. No. 5 TELL'S BELLS charted with a "dx"(driver caused break) and a DNF (did not finish).
