Race 5 – Inquiry posted on unofficial race winner No. 5 ROSARITO BEACH N (Mike Peterson) for possible pylon violation past the quarter entering the backstretch. Video showed that driver Peterson was inside two pylons for sure. However, the judges determined that the horse did not gain an unfair advantage and was not lapped on at the finish. No reason for placing. Driver Peterson fined \$100.00 for a pylon violation.

Race 9 - No. 1 CALL ME DANI (Brad Ferguson) originally finished fifth placed sixth for a pylon violation past the quarter up the backstretch. The horse was inside at least six pylons and striking pylons with his inside legs. Brad Ferguson fined \$200.00 for a pylon violation causing a placing.
