ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 3 – General inquiry posted looking at an incident in the stretch. After reviewing video of the incident the judges determined no placings were no necessary and left the order of finish unchanged.

Race 4 – Inquiry posted on unofficial fourth place finisher No. 5 TOPVILLE OHSOLUCKY (Marvin Luna) for possible interference to No. 3 VINTAGE QUEEN (Brad Ferguson) in the stretch. Video showed that No. 5 TOPVILLE OHSOLUCKY struck the wheel and flattened the tire of No. 3 VINTAGE QUEEN. This was confirmed by both driver Brad Ferguson and by starter Todd Nixon who called it up from the gate. No. 5 TOPVILLE OHSOLUCKY finished fourth placed seventh. Driver Marvin Luna fined \$200.00 for interference causing a placing.

Race 6 – Brandon Bates, driver of No. 2 C'MON MAX, fined \$100.00 for laying straight back in the sulky at the finish.

Race 8 - Inquiry posted on unofficial second place finisher #7 MAJOR VELOCTTY (Brad Ferguson) for possible violation of the breaking rule before the quarter. Video confirmed that Mr. Ferguson complied with all aspects of the breaking rule and the horse was placed as finished.

Race 9 – Ronald Burks, driver No. 4 RB'S ENDOFANERA, warned about using too much elbow action while whipping in the stretch.

Race 10 – With the scratches of No. 2 BEAUEASTEL and No. 4 FIRST OPTION, the field was reduced from six to four betting interests. Per IHRC wagering rules, trifecta and superfecta wagering on the race cancelled. The track opted to cancel show wagering as well.
