i. ICRC/Darian Day v. Jerry Wenger (HOha23090705)

Submitted to the Commission October 4, 2024

The ALJ in this matter determined the Respondent in this matter violated the Indiana Civil Rights Law by engaging unlawful retaliation in the protected area of housing. The Complainant is awarded compensatory damages of nine thousand, seven hundred dollars (\$9700.00), emotional damages of twenty-five thousand dollars (\$25,000.00). The Respondent is ordered to cease and desist from discriminative acts and retaliating against people because of a protected activity. The Respondent filed an Objection and Appeal to the decision by the ALJ and the Complainant has filed their Response to the Respondent's Objection. The Oral Argument is scheduled for today.

ii. Shannon Black v. Park Hospitality, LLC d/b/a Best Western Plus Northwest (EMha23050495)

Submitted to the Commission Nov. 8, 2024

The Administrative Law Judge ("ALJ") in this matter determined the Respondent is in Default, and must pay damages in the amount of four hundred ninety-one dollars and eighty-four cents (\$491.84) to Complainant, along with ceasing and desisting from discriminating against people on the basis of disability in the protected area of employment and taking the steps to make sure that it does not happen again. ICRC Staff Counsel, Frederick S. Bremer, on behalf of the Complainant, Gregory L. Wilson, Sr., in his capacity as Director of the Indiana Civil Rights Commission submitted Complainant's Objections to the Recommended Findings Of Facts, Conclusions to Law and Order. Oral arguments scheduled for today have been continued.
