The ALJ in this matter has determined that the Respondent in this matter did indeed violate the Indiana Fair Housing Act and the Indiana Civil Rights Law regarding the Complainant on the basis of discriminating against people with disabilities and regarding unlawful retaliation in the protected area of housing. The Complainant is awarded compensatory damages of nine thousand, seven hundred dollars (\$9700.00), emotional damages of twentyfive thousand dollars (\$25,000.00). The Respondent is ordered to cease and desist from discriminative acts and retaliating against people because of a protected activity. The Respondent in this matter has filed an objection, the Complainant has thirty (30) days to file an Response, so no decision on this matter is due at this time.
