Background:

- Liberty Landfill is a municipal solid waste landfill owned and operated by Liberty Landfill LLC. It is located at 8635 East State Road 16, Monticello, Ind. 47960 in White County. The landfill accepts for disposal municipal solid waste, industrial waste, construction & demolition waste, and C-Soil.
- On Nov.2, 2023, Liberty Landfill LLC submitted a major permit modification application which can be found in the Indiana Department of Environmental Management's (IDEM) online Virtual File Cabinet (VFC) (VFC #83692646). The company also submitted additional information related to the permit modification dated July 2, 2024 (VFC #83667287), and July 3, 2024 (VFC #83664334).
- The application proposes to:
 - Expand the facility boundary from approximately 169.1 acres to approximately 608.334 acres
 - Expand the solid waste boundary for the landfill by approximately 100.958 acres. The current permitted acreage is 169.144 acres.
 - Increase the available volume of the landfill from 35,992,000 cubic yards to 62,362,94 cubic yards, a proposed expansion of 24,532,000 cubic yards. Most of the volume increase is due to the horizontal expansion of the landfill. There is minor vertical expansion increase at the interface of the existing solid waste boundary and horizontal expansion.
- Liberty Landfill LLC will hold a public meeting regarding the application on Friday, Sept. 20, 2024, from 1:30 p.m. to 2:30 p.m. ET in the Program Room at the Monticello-Union Township Public Library located at 321 West Broadway Street, Monticello, Ind. 47960. A brief description of the location and proposed changes will be presented and there will be an opportunity for public comments and questions.
- This fact sheet contains information about the proposed modification, the process for issuing the permit, and opportunities for public participation.

IDEM's Role

- IDEM is responsible for protecting human health and the environment while providing for safe industrial, agricultural, commercial, and governmental operations vital to a prosperous economy.
- Properly designed and operated landfills provide a safe place to dispose of waste and protect Hoosiers and our environment by preventing the accidental release of harmful pollutants to air, land, and water.
- Municipal Solid Waste Landfill owners and operators must obtain a major modification permit for any
 horizontal expansion greater than either one acre or more than 10% of the landfill's existing capacity,
 and construct and operate it according to Indiana's rules for solid waste land disposal facilities. These
 rules are found in the Indiana Administrative Code at 329 IAC 10. The rules require a wide range of
 engineered systems to protect the environment.
- IDEM's Office of Land Quality is responsible for reviewing landfill permit applications. Engineers and geologists evaluate the landfill design drawings and operating plans to be sure they meet or exceed the rule requirements before granting a permit or approving modifications to a permit.



In addition to issuing approvals and permits that comply with federal and state environmental
regulations designed to protect public health and our environment, IDEM is also responsible for
overseeing permitted activities and monitoring compliance at permitted facilities.

Citizen's Role

- You can review the application and related correspondence online at IDEM's Virtual File Cabinet (VFC) web site using the following steps:
 - Go to <u>idem.IN.gov/legal/public-records/virtual-file-cabinet/</u>, which is the VFC's "Document Search" page.
 - Once there, click on the blue box labeled Virtual File Cabinet.
 - Select the Quick Search dropdown arrow in the upper right corner of the screen.
 - Select SW Program ID (Solid Waste).
 - o Enter the SW Program ID, **91-04**, in the box to the right of the Quick Search box.
 - Click the blue Search arrow, which will create a list of links to the documents for this facility. Click on the 'Document Date' column header to sort the documents by date.
 - The date in the Document Date column will match the document date noted in this Fact Sheet. Click the highlighted numbers in the *Content Id* column to view individual documents.
 - o Click on the dropdown menu **Page** *x out of y* or the green navigation arrows on either side of the box to open additional pages containing additional documents.
