

## NOTICE OF RECEIPT OF COMPLETE APPLICATION

On November 11, 2022, the Indiana Department of Environmental Management (IDEM) received a closure/post-closure plan from Duke Energy Indiana, LLC at 30 Jackson Street, New Albany, Floyd County. The closure/post-closure plan and additional information received November 17, 2023 has been determined to be complete. IDEM's determination of completeness initiates a public comment period during which IDEM will accept comments from the public regarding the closure/post-closure plan. Comments must be submitted within 30 days of the date of this newspaper publication of the Notice.

Following the end of the public comment period, IDEM will issue a Notice of Decision (NOD) stating whether the approval has been issued or denied. If comments are received during the public comment period, the final decision will include a document that summarizes the comments and IDEM's response to those comments. If you have submitted comments or have asked to be added to the mailing list, you will receive the NOD. The notice will provide details on how you may appeal IDEM's decision, if you disagree with that decision. The final decision will also be available online via the Virtual File Cabinet, and at the New Albany - Floyd County Public Library, subject to the possible limitations noted above due to the COVID-19 pandemic.

You may request that IDEM hold a public hearing. Public comments and supporting documentation, or a request for a public hearing should be emailed in writing to IDEM at [LHummel@idem.IN.gov](mailto:LHummel@idem.IN.gov); email is preferred. You may also submit written comments by mailing them to the address below.
