## To all interested parties:

This letter shall serve as a formal notice of the receipt of an application for **Section 401 Water Quality Certification** by the Indiana Department of Environmental Management (IDEM). The purpose of the notice is to inform the public of active applications submitted for water quality certification under Section 401 of the Clean Water Act (33 U.S.C. § 1341) and to solicit comments and information on any impacts to water quality related to the proposed project. IDEM will evaluate whether the project complies with Indiana's water quality standards as set forth at 327 IAC 2.

4. Affected waterbody: Unnamed Tributary (UNT) to Big Blue River

5. Project Description:

The existing bridge carrying State Road 140 over Big Blue River will be replaced with a new 3-span bridge located approximately 65 feet north of the existing structure. Due to the grading of the new approach road and the placement of riprap around the bridge abutment slopes, 151.5 linear feet of UNT to Big Blue River will be relocated 15 feet to the east. Mitigation will be provided through the purchase of 151.5 linear feet of stream credits from the Whitewater-East Fork White service area of the Indiana Stream and Wetland Mitigation Program (DISWAR).

The request for a hearing should be submitted within the comment period to be considered timely. The request should also state the reason for the public hearing as

specifically as possible to assist IDEM in determining whether a public hearing is warranted.
