### **Transfer of Ownership**

Pursuant to 327 IAC 5-2-6(c), the parties have notified the Indiana Department of Environmental Management (IDEM) of their intention to transfer IWP Permit INP000670 from Inventure Foods Inc., the "current permittee" and previous owner of the facility, to Super-Pufft, the "transferee" and future owner of the facility, effective as of May 21, 2024.

The current permittee acknowledges liability for violations up to the proposed date of permit transfer, and the transferee acknowledges liability for violations on and after the proposed date of permit transfer.

The transferee certifies that it is its intention to operate the facility for which IWP Permit INP000670 is issued without making such material and substantial alterations to the facility as would significantly change the nature or quantities of pollutants discharged, and thus constitute cause for permit modification under 327 IAC 5-2-16(d).
