To all interested parties:

This letter shall serve as a formal notice of the receipt of an application for **Section 401 Water Quality Certification** by the Indiana Department of Environmental Management (IDEM). The purpose of the notice is to inform the public of active applications submitted for water quality certification under Section 401 of the Clean Water Act (33 U.S.C. § 1341) and to solicit comments and information on any impacts to water quality related to the proposed project. IDEM will evaluate whether the project complies with Indiana's water quality standards as set forth at 327 IAC 2.

4. Affected waterbody: Two(2) Unnamed Tributaries(UNT) to Coal Creek

5. Project Description: The existing corrugated metal pipe carrying UNT 1 to Coal Creek under US 41 will be lined with a 78-inch diameter by 357 foot long high density polyethylene (HDPE) pipe, grouted riprap will be placed along 44 linear feet of the outlet of this structure. Additionally, the existing concrete channel liner within UNT 2 to Coal Creek will be removed and replaced with 40 linear feet of riprap. Mitigation is proposed through the purchase of 84 linear feet of stream credits from the Indiana Stream and Wetland Mitigation Program (INSWMP). Comment period: Any person or entity who wishes to submit comments or information relevant to the aforementioned project may do so by the closing date noted above. Only comments or information related to water quality or potential impacts of the project on water quality can be considered by IDEM in the water quality certification review process.

Public Hearing: Any person may submit a written request that a public hearing be held to consider issues related to water quality in connection with the project detailed in this notice. The request for a hearing should be submitted within the comment period to be considered timely. The request should also state the reason for the public hearing as specifically as possible to assist IDEM in determining whether a public hearing is warranted.

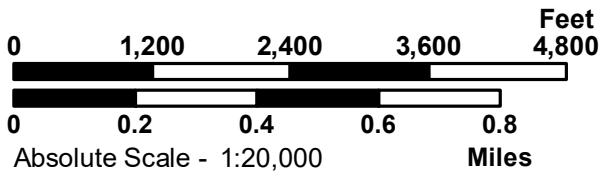

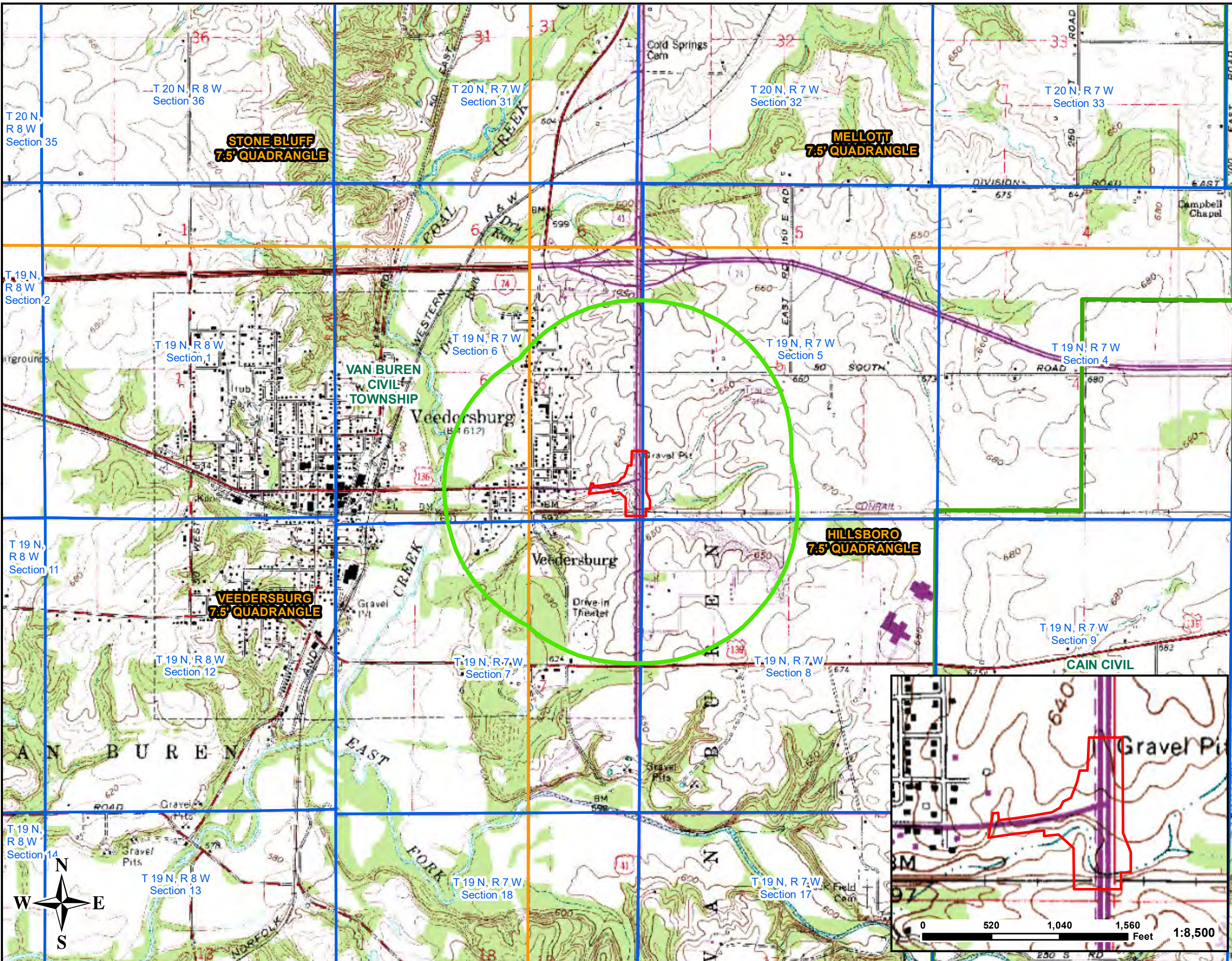

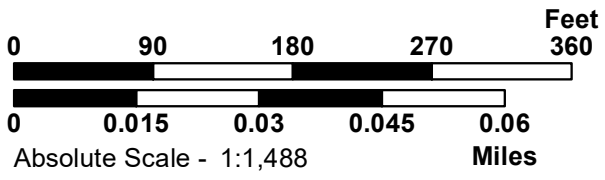
US 41 at UNT to Coal Creek
