

To all interested parties: This letter shall serve as a formal notice of the receipt of an application for a **State Isolated Wetland Individual Permit** by the Indiana Department of Environmental Management (IDEM). The purpose of the notice is to inform the public of active applications submitted for permits required under IC 13-18-22 and to solicit comments and information on any impacts to water quality related to the proposed project. IDEM will evaluate whether the project complies with Indiana's water quality standards as set forth at 327 IAC 2 and all applicable provisions of IC 13-18-22.

5. Project Description:		A new turn lane will be added from eastbound State Road 56 onto north bound Slab Road. This project will result in 0.29 acre of impacts to two(2) emergent wetlands due to roadway widening. Mitigation will be provided through the purchase of 0.44 acre of wetland credits from the Indiana Stream and Wetland Mitigation Program (INSWMP). The request for a hearing should be submitted within the comment period to be considered timely. The request should also state the reason for the public hearing as specifically as possible to assist IDEM in determining whether a public hearing is warranted.
