TITLE 327 INDIANA DEPARTMENT OF ENVIRONMENTAL MANAGEMENT LSA Document #23-810

I. Continued Need for the Rule

This rulemaking is required under IC 4-22-2.6, which provides for the expiration and readoption of administrative rules. All rules expire on January 1 of the fifth year after the year in which each rule takes effect unless the rule expires or is repealed on an earlier date. The rules listed to be readopted have an expiration date of January 1, 2025, or later. IDEM has chosen to readopt all articles in the Indiana Administrative Code at one time rather than readopt each rule separately as its expiration date approaches.

The rules to be readopted comprise Title 327 of the Indiana Administrative Code. In general, these rules regulate water quality in Indiana. The rules include both statutorily and federally required permit programs that prevent and mitigate water pollution. IDEM has reviewed these rules and found they are needed to not only fulfill statutory and federal requirements, but also protect Indiana residents from the harmful effects of water pollution and protect water quality within the state.

II. Analysis of fees, fines, and civil penalties under IC 4-22-2-19.6

All fees in Title 327 were adopted prior to January 1, 2023. These fees are necessary to fund relevant permitting programs and echo what is already in statute. More details on these fees can be found in the Revised Regulatory Analysis section.

III. Complaints and Comments

There have been no complaints or comments received from the public concerning the readoption of these rules.

IV. Difficulties Encountered

There have been no difficulties encountered by either the agency in administering the rule or by regulated parties in complying with the rule. The articles being readopted in this notice include both federally mandated U.S. EPA regulations under the Clean Water Act and the Safe Drinking Water Act, state-specific rules necessary to fulfill federal requirements, and statutorily required rules.

V. Changes in Technology, Economic Conditions, or Other Factors

The rules being readopted have been reexamined and the agency has determined that changes in technology, economic conditions, or other factors have not affected their readoption.
