

- Benchmarking: Compare your organization's healthcare costs against state and regional benchmarks to evaluate the cost-effectiveness of your benefits programs.










Improved Health Outcomes

- Preventive Care Strategies: Leverage data to encourage preventive care, reducing long-term healthcare costs.







Participation

How the Indiana APCD Works

Indiana APCD

- Data Collection: Employers, through their benefits administrators or thirdparty administrators (TPAs), submit de-identified healthcare claims data to the APCD.
- **Data Aggregation:** The APCD aggregates and standardizes the data from all contributors, ensuring consistency and privacy.
- Data Analysis: The database generates reports and insights on healthcare utilization, cost trends, and quality metrics.
- Stakeholder Access: Employers can access tailored reports to guide decision-making while adhering to strict data privacy and security standards.

Employer Participation

Indiana APCD

Participating in the Indiana APCD is simple and impactful. Employers are encouraged to:

- Engage Benefits Administrators: Request your benefits administrators or TPAs to incorporate claims data into the APCD through data submission. Chances are, they are already submitting data to the Indiana APCD, they would simply need to incorporate your companies' data with their monthly submission.
- Collaborate with the APCD Team: Work with the Indiana APCD to ensure seamless data submission and access to actionable reports.
- Leverage Insights: Use APCD-generated insights to drive meaningful improvements in your healthcare strategy.
