MOTION TO LIFT SUSPENSION

The Enforcement Division of the Indiana Department of Insurance (“Department”), by counsel, Joseph Bossinger, now moves that the Suspension Order issued on January 30, 2024, in this matter be lifted. In support of this request, the Department asserts the following:

1. Devin Caldwell (“Respondent”) is a nonresident insurance producer holding license #3767136 since January 31, 2022;
2. On January 9, 2024, the Commissioner of the Indiana Department of Insurance (“Commissioner”) mailed Respondent a certified letter requesting a list of appointments;
3. More than ten (10) days elapsed since the Commissioner requested a list of appointments without a response from Respondent;
4. Pursuant to Indiana Code § 27-1-15.6-12(g), on January 30, 2024, the Commissioner issued a Suspension Order suspending Respondent’s license #3767136 until such time as the Commissioner received Respondent’s list of appointments;
5. On February 27, 2024, Respondent sent an email to the Department providing a list of Respondent’s appointments.

WHEREFORE, the Department respectfully requests that the Commissioner issue an order lifting the suspension of Respondent's license, and for all other relief just and proper in the premises.
