ADMINISTRATIVE ORDER NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance ("Department"), pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 et seq., and Indiana Code § 27-1-15.6-12, hereby gives notice to Beauregard Ray, ("Respondent") of the following Administrative Order:

- Respondent is a licensed nonresident insurance producer, holding license number 851944 ("Respondent's license") since November 8, 2012.
- 2. Respondent's license expired on October 31, 2023.
- 3. On October 3, 2023, Respondent submitted a renewal application and failed to disclose the following administrative actions:
 - a. December 19, 2019, revocation issued by the Washington State Office of the Insurance Commissioner.
 - b. July 13, 2020, revocation issued by the Oregon Division of Financial Regulation.
 - c. November 10, 2020, revocation issued by the Delaware Department of Insurance.
 - d. December 9, 2020, revocation issued by the South Dakota Division of Insurance.

- e. June 4, 2021, revocation issued by the Virginia State Corporation Commission.
- f. November 17, 2021, revocation issued by the North Carolina Department of Insurance.
- g. December 10, 2021, revocation issued by the Missouri Department of Insurance.
- h. June 17, 2022, denial issued by the North Carolina Department of Insurance.
- September 8, 2022, revocation issued by the New York State Department of Financial Services.
- j. November 4, 2022, revocation issued by the Arkansas Insurance Department.
- 4. Indiana Code § 27-1-15.6-12(b)(1) provides, in part, that the Commissioner may refuse to renew an insurance producer's license for providing incorrect, misleading, incomplete, or materially untrue information in a license application.
- 5. Indiana Code § 27-1-15.6-12(b)(9) provides, in part, that the Commissioner may refuse to renew an insurance producer's license for having an insurance producer license, or its equivalent, denied, suspended, or revoked in any other state, province, district, or territory.
- 6. Indiana Code § 27-1-15.6-12(d) requires the Commissioner to notify a licensée of the reason for the nonrenewal of Respondent's license. This Order serves as that notice.
- 7. The Commissioner notifies Respondent that, pursuant to Indiana Code § 27-1-15.6-12(d), Respondent may, within sixty-three (63) days of the mailing of this Order, make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.
- 8. This is considered an administrative action by the Indiana Department of Insurance. If you choose to appeal this administrative action, please follow the aforementioned instructions.

Subsequently, after the Department has received your written request for a hearing, the State of Indiana Office of Administrative Law Proceedings ("OALP") will assign an administrative law judge to preside over this matter, and you will receive more information from OALP to begin the administrative process.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies Respondent that Respondent's license shall not be renewed due to Respondent's nine (9) license revocations, one (1) license denial, and for failure to disclose the same on Respondent's renewal application.
