## FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Agnes T. Collins ("Respondent") is a nonresident insurance producer holding license number 3885421 since March 27, 2023;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request within ten (10) days of receiving a request;

WHEREAS, on February 29, 2024, the Commissioner sent certified mail # 7015 1520 0003 1680 7611 to Respondent's address of record requesting a list of appointments;

WHEREAS, on April 29, 2024, certified mail article # 7015 1520 0003 1680 7611 was returned to the Indiana Department of Insurance;

WHEREAS, on February 29, 2024, Respondent was sent the same appointment requests to the Respondent's email address of record which included a request for "delivery receipt," which was received by the Department on the same day and indicated the email to Respondent was successfully delivered;

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner's request;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days is a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in her sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 3885421 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
