## ADMINISTRATIVE ORDER AND NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance ("Department"), pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 et seq., and Indiana Code § 27-1-15.6-12, hereby gives notice to Brian D. Turner ("Respondent") of the following Administrative Order:

- Respondent is a licensed nonresident insurance producer holding license number 852102 ("Respondent's license") since November 8, 2012.
- 2. Respondent's license expired on August 31, 2023.
- 3. On or about September 16, 2021, Respondent was charged with Solicitation of Prostitution, a State Jail Felony, in Bell County, Texas.
- 4. On or about July 14, 2022, Respondent was sentenced to a term of two years of deferred adjudication probation for Solicitation of Prosecution, in Bell County, Texas.
- 5. Respondent failed to report Respondent's criminal prosecution to the Department.

- 6. Indiana Code § 27-1-15.6-12(b)(2)(A) states, in part, the Commissioner may refuse to renew an insurance producer license for violating an insurance law.
- 7. Indiana Code § 27-1-15.6-17(b) is an insurance law that states, in part, not more than thirty (30) days after an initial pretrial hearing date, a producer shall report to the Commissioner any criminal prosecution of the producer initiated in any jurisdiction.
- 8. Indiana Code § 27-1-15.6-12(d) requires the Commissioner to notify a licensee of the reason for the nonrenewal of the licensee's license. This Order serves as that notice.
- 9. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-15.6-12(d), Respondent may, within sixty-three (63) days of the mailing of this Order, make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.
- 10. This is considered an administrative action by the Indiana Department of Insurance. If you choose to appeal this administrative action, please follow the aforementioned instructions. Subsequently, after the Department has received your written request for a hearing, the State of Indiana Office of Administrative Law Proceedings ("OALP") will assign an administrative law judge to preside over this matter, and you will receive more information from OALP to begin the administrative process.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies Respondent that Respondent's license shall not be renewed due to the Respondent failing to report Respondent's criminal prosecution to the Department not more than thirty (30) days after the initial pretrial hearing.
